-74% 2,076 (350)(146)(105)(885)(58)532 2019 Price Volume Others 2020 Impairment of Effect of tax refunds income tax exemption


Challenging macro economic conditions:

- 5- Lowered Global GDP growth



Revenue (QR' billion)




Net profit (QR' billion)




Production and Sales Volumes


