MPHC DECLARES NET PROFIT OF QR 1.4 BILLION FOR THE YEAR ENDED 31 DECEMBER 2018

- **Profits significantly up from previous year by 28%.**
- **Strong liquidity position with closing cash of QR 1.9 billion as at 31 December 2018.**
- **Tax refund of QR 169 million booked during the year.**

DOHA, QATAR - 14/02/2019: Mesaieed Petrochemical Holding Company (“MPHC” or “the group”; QE: MPHC), a subsidiary of Qatar Petroleum and one of the region’s premier diversified petrochemical conglomerates with interests in the production of olefins, polyolefins, alpha olefins and chlor-alkali products, announced its financial results for the year ended 31 December 2018 with net profit of QR 1.4 billion.

Financial Results

MPHC posted a robust net profit of QR 1.4 billion for the year ended 31 December, 2018 with earnings per share of QR 1.11, outperforming its previous year’s net profit of QR 1.1 billion with earnings per share of QR 0.87 by QR 306 million or 28%. The year-on-year surge in profit was due to higher group sales volumes and selling prices. The profit for the year was also aided by the recognition of a tax refund of approximately QR 169 million during the year.

The group continued to benefit from the supply of competitively priced Ethane feedstock and Fuel gas under long-term supply agreements. QChem and QChem II also benefitted from the increased availability of feedstock of 8% during the year through separate agreements. These contractual arrangements are an important value driver for the group to sustain its strong profitability in a highly competitive market environment.

Financial Position and Cash flows

The closing cash position as at 31 December, 2018 after distribution of the previous years’ dividends of QR 855 million, was a robust QR 1.9 billion. The total assets as at 31 December, 2018 was QR 15.3 billion, compared to QR 14.8 billion as at 31 December, 2017.

Proposed Dividend Distribution

The Board of Directors therefore recommends a total annual dividend distribution for the year ended 31 December, 2018 of QR 1.0 billion, equivalent to a payout of QR 0.8 per share representing 72% of the group’s profit. The distributions since inception including the proposed distribution for 2018 amounts to QR 5.3 billion.

("MPHC") was incorporated as a Qatari joint stock company on May 29, 2013 with an agreed effective date for the transfer of Qatar Petroleum's previous shareholding in the joint ventures of September 1, 2013. The registered office is located at P.O. Box 3212, Doha, State of Qatar. The main activity of MPHC is to act as a holding company: (i) Q-Chem is currently owned by MPHC (49%), Chevron Phillips Chemical International Qatar Holdings L.L.C. ("CPCIQH") (49%) and QP (2%), and has one wholly-owned subsidiary, Q-Chem Distribution Company Limited, (ii) Q-Chem II is currently owned by MPHC (49%), CPCIQH (49%) and QP (2%), and has one wholly-owned subsidiary, Q-Chem II Distribution Company Limited, and an effective ownership interest of 53.85% in a joint venture, Ras Laffan Olefins Company Limited, which supplies ethylene to Q-Chem II; and (iii) QVC, which was incorporated in 1997 as a joint venture, and is currently owned by MPHC (55.2%), Qapco (31.9%) and QP (12.9%).
